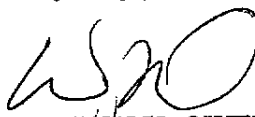

ARTICLES OF INCORPORATION OF WEBMART, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopt the following articles of incorporation:

ARTICLE ONE. NAME. The name of the corporation is WEBMART, Inc.

ARTICLE TWO. PRINCIPAL OFFICE. The street address of the initial principal office of the corporation is 108-A DeBarry Avenue, Orange Park, Florida 32073.

ARTICLE THREE. CORPORATE DURATION. The duration of the corporation is perpetual.

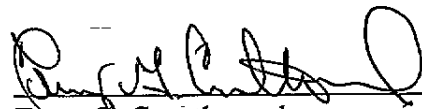

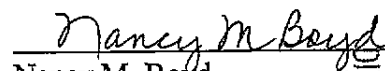
