ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of this corporation is JUSDANCING, INC.

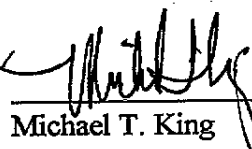
The corporation shall indemnify any Officer or Director, or any former Officer or Director to the full extent permitted by law.

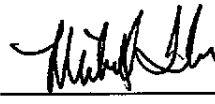

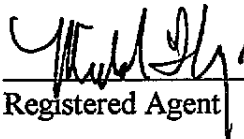
