NAME

The name of the corporation is:

DURATION

This Corporation shall have perpetual existence.

INDEMNIFICATION


The Corporation shall indemnify any officer, director, employee or agent or any former officer, director, employee or agent to the full extent permitted by law.

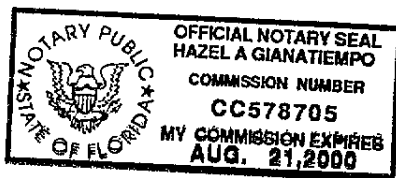


