

ARTICLES OF INCORPORATION

OF

KARDATZKE MANAGEMENT, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation shall be: KARDATZKE MANAGEMENT, INC. The principal place of business of this corporation shall be 701 Destacada Avenue, Coral Gables, Florida 33156.

ARTICLE II. NATURE OF BUSINESS

The nature of the business is to engage in any lawful act or activity for which corporations may be organized under the laws of the State of Florida as presently in effect or as it may hereafter be amended.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to issue is 10,000 shares of common stock having a par value of \$.01 per share.


