ARTICLES OF INCORPORATION

OF

AFTER THE RAIN, INC.

ARTICLE I - NAME AND ADDRESS

The name of the Corporation shall be AFTER THE RAIN, INC. with its principal place of business at 824 Highland Street, Sarasota, Florida 34234.

ARTICLE II - NATURE OF BUSINESS
