OF
JCH HOLDINGS, INC.**

ARTICLE I

The name of the corporation is **JCH Holdings, Inc.**

ARTICLE II

This corporation's existence shall become effective as of February 24, 1998.

ARTICLE III

The corporation is organized for the purpose of transacting any or all lawful business for which corporations may be organized under the Florida Business Corporation Act of the State of Florida.

ARTICLE VI

The mailing address of the principal place of business of the corporation is 700 Universe Boulevard, Juno Beach, Florida 33408.

ARTICLE V

The aggregate number of shares which the corporation shall have authority to issue is 1,000 shares, voting common stock, par value \$.01 per share, and 250 shares, non-voting preferred stock, par value \$10.00 per share.

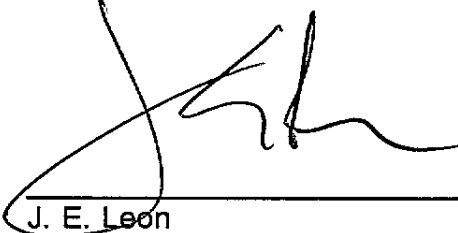
