The undersigned do hereby make, subscribe, acknowledge and file the following articles for the purpose of becoming a corporation under the laws of the State of Florida.

ARTICLE I.

The name of the corporation shall be:

SOUTHERN GROUND SUPPORT, INC.

ARTICLE II.

The general nature of the business to be transacted by the corporation shall be as follows:

To conduct the business of purchasing, selling, installing, reparing, maintaining, supporting and consulting on all facets of the aviation ground support business and similar endeavors and to perform all acts as may be necessary to accomplish the foregoing purpose of the corporation.
