Name

The name of the corporation is WASHFRUIT CORP.

ARTICLE II

Duration

This corporation shall have a perpetual existence, unless dissolved according to law, commencing on the 20th day of FEBRUARY, 1998.

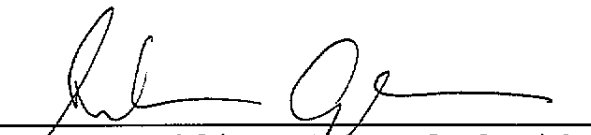

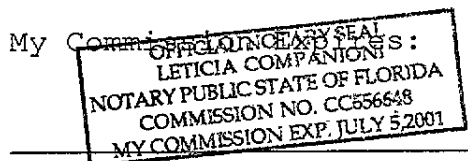
