

ARTICLE II: DATE DISSOLUTION WAS AUTHORIZED


The dissolution of this Corporation was authorized by written consent of its Sole Shareholder on November 18, 1998.

ARTICLE IV: EFFECTIVE DATE OF DISSOLUTION


