ARTICLE ONE. NAME

The name of the corporation is MARINE OUTLET CENTER, INC.

ARTICLE TWO. PURPOSE

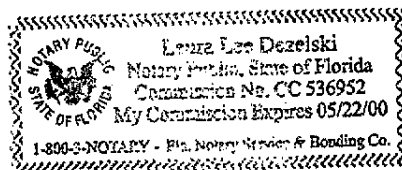
