ARTICLES OF INCORPORATION
OF

ARTICLE I

CORPORATE NAME:

The name of this corporation is: SERENGETI DIAMONDS U.S.A., INC.

ARTICLE II

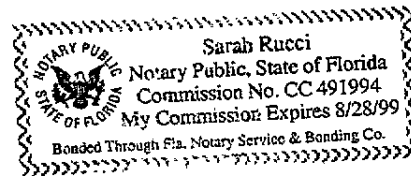
