# ARTICLES OF INCORPORATION

of

The undersigned, for the purpose of forming a corporation under the provisions of the statutes of the State of Florida, does hereby adopt the following Articles of Incorporation.

# ARTICLE I

**NAME** 

The name of the corporation is:

# **ARTICLE II**

**DURATION** 

This corporation shall have a perpetual existence.

ARTICLE III

**PURPOSE** 

This corporation is organized to:

To transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

## ARTICLE IV

### CAPITAL STOCK

The aggregate number of shares which the corporation is authorized to issue is 1000 shares of stock having a par value of \$1.00 per share. All shares of stock shall be designated as common shares. 
