**FIRST:** The corporate name that satisfies the requirements of section 607.040 is Flamingo Ford, Inc.

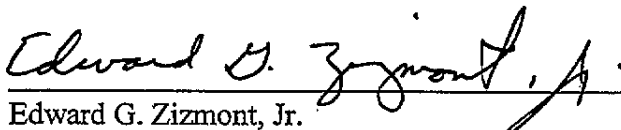
