# ARTICLES OF INCORPORATION OF CCH DALLAS I, INC.

THE UNDERSIGNED, FOR PURPOSES OF FORMING A CORPORATION UNDER THE FLORIDA GENERAL CORPORATION ACT, HEREBY ADOPT THE FOLLOWING ARTICLES OF THE INCORPORATION:

## ARTICLE I - NAME


