ARTICLE I

The name of the corporation is : MASTERS UNIVERSE DRYWALL, INC.

ARTICLE II

This corporation is organized for the purpose of transacting any or all business permitted under the laws of the United States of America and the laws of the State of Florida

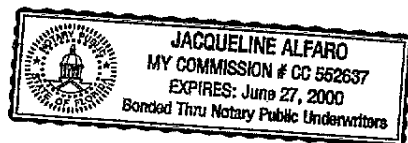
