NAME

The name of this corporation is: Go Enterprises, Inc.

ARTICLE 2

DURATION



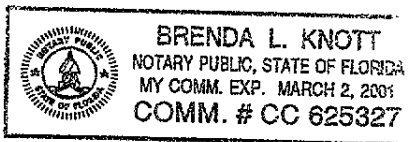



