

ARTICLES OF INCORPORATION  
OF

ARTICLE I - NAME

The name of the corporation is INTERCOASTAL DISTRIBUTORS OF NORTH FLORIDA, INC..

ARTICLE II - DURATION

The corporation shall have perpetual existence commencing on the date of execution and acknowledgement of these Articles.

ARTICLE III - PURPOSE

The corporation is organized for the following purposes:

A. To import, buy, sell, and generally deal in ceramic tile of all types and descriptions, at wholesale and retail, and to acquire real and personal property necessary to conduct said business.

B. To engage in any activities or business permitted under the laws of the United States or the State of Florida.


