ARTICLE I * NAME AND ADDRESS

The name of this corporation is ASAP Graphix & Signs, Inc. and its principle place of business shall be at 2830 Wilderness Road, West Palm Beach, Florida 33409.

ARTICLE II * DURATION

This corporation is to exist perpetually.

ARTICLE III * PURPOSE

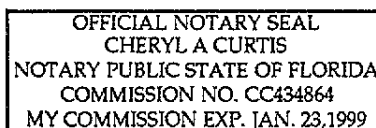
