### Woman charged in theft of client list

TARPON SPRINGS — Police have charged a Clearwater woman with taking the client list from her former employer in an effort to use the information at a competing company she was starting. Gabrielle T. Snapp, 51, of 644 Island Way, No. 401, was employed by Exactitude Beauty Inc. in Tarpon Springs when she put together a client list from the company's database, police said. She was fired from the company, a distributor of Bronzini beauty products, and started a rival company, police said. She sent several e-mails to her brother in which she admitted using the information from Exactitude's database, said Tarpon Springs police Sgt. Allen MacKenzie, who investigated the case along with Detective Khrist Walguarnery. For her new business, she also had ordered thousands of dollars of beauty products that she planned to sell under the name Bronzeen, MacKenzie said. After a monthlong investigation that started with a complaint by Exactitude owner Roberto Decio, Snapp surrendered Tuesday. She was released Tuesday from Pinellas County Jail on her own recognizance. She faces a charge of theft

of trade secrets, a third-degree felony.

### Homemade bomb toss leads to arrest

PALM HARBOR — A homemade bomb explosion Tuesday afternoon led to the arrest of Sean McLaughlin, 19, of 4384 Fallbrook Blvd. in Palm Harbor. Charged with making and throwing a destructive device, McLaughlin was released Wednesday from Pinellas County Jail after posting \$20,000 bail. Arrest records show a bomb made from household chemicals and a plastic soda bottle was tossed into the street at 1834 Eagle Trace Blvd. McLaughlin was accused of helping make the bomb and tossing it.
