ARTICLES OF INCORPORATION

OF

BARLEY'S SUPERSTORE, INC.

The undersigned, acting as the sole incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

NAME AND ADDRESS

The name of the corporation is Barley's Superstore, Inc. The address of the corporation is 6300 Taylor Road, Naples, Florida 34109.

SHAREHOLDERS' PROPERTY


