

ARTICLES OF INCORPORATION OF

MILLENIA MORTGAGE, CORP.



The undersigned, acting as incorporator of MILLENIA MORTGAGE, CORP. under the Florida General Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is: MILLENIA... MORTAGE, CORP.
