

## ARTICLES OF INCORPORATION

The undersigned, acting as incorporators under the Florida General Corporation Act, adopt the following articles of incorporation for such corporation:

1. The name of the corporation is Q-TEK NETWORK, INC., whose mailing address is 4899-B West Waters Avenue, Tampa, Florida 33634.
2. The period of its duration is perpetual.
3. The purpose is to engage in any activities or business permitted under the laws of the United States and Florida.

6. The number of directors constituting its initial Board of Directors is two (2) whose names and addresses are:






