Article I. The name of the Corporation shall be: Boca Raton Fishing Club, Inc.

Article II. The principle place of business and mailing address of this Corporation shall be: 16267 Fig Way, Delray Beach, Florida 33484.

Article III The Boca Raton Fishing Club is organized to promote sport fishing and conservation in the inshore and near shore waters of southern Palm Beach County. The club is also dedicated to promoting fishing activities to the youths of the area.

Article IV The First Board of Directors will serve for a term of not more than five (5) years. At the end of that term the Board will nominate and elect a new board of directors, consisting of no less then three nor more than 5 members. A member receiving a simple majority of the Board members voting in that election will be considered elected to the Board of Directors. The Board will initially consist of five members. The Board may expand the number of directors with a 3/5 majority vote in favor of expanding the number of directors.

In the event of a vacancy of a director position, the board may fill the vacancy with a majority of the board members present to vote. At no time shall there be less than three directors.
