ARTICLES OF INCORPORATION

OF

AUTOMOTIVE SERVICES OF S.W. FLORIDA, INC.



ARTICLE ONE

The name of this corporation is AUTOMOTIVE SERVICES OF S.W. FLORIDA, INC. and the mailing address of the corporation shall be 2709 Meadow Lane, Fort Myers, FL 33901.

ARTICLE TWO

The date of the commencement of corporate existence of the corporation shall be the date these Articles are executed.

ARTICLE THREE

The duration of the corporation is perpetual.

ARTICLE FOUR

The general purposes for which the corporation is organized are:

- 1. To engage in the business of a motor vehicle repair shop.
- 2. To transact any other lawful business for which corporation may be incorporated under the Florida General Corporation Act.
- 3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.
