ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I

NAME

The name of this corporation is BRUCE R. LIEBERMAN, P.A.

ARTICLE II

NATURE OF BUSINESS

This corporation shall have the power to transfer or engage in any business permitted under the laws of the United States and the State of Florida and is a legal professional corporation which can engage in the practice of law, the shares of which may be owned only by persons admitted to the bar of the State of Florida.

ARTICLE III

AUTHORIZED SHARES

The capital stock of this corporation shall consist of 1,000 shares of common stock having a par value of \$.001 per share.

ARTICLE IV

INITIAL CAPITAL

The amount of capital with which this corporation shall commence business shall not be less than One Hundred Dollars (\$100.00).

## ARTICLE V

### TERM OF EXISTENCE

This corporation shall have perpetual existence.

## ARTICLE VI

### INITIAL ADDRESS

The initial address of the principal place of business of this corporation in the State of Florida shall be 3181 McDonald Street, Coconut Grove, Florida 33133. 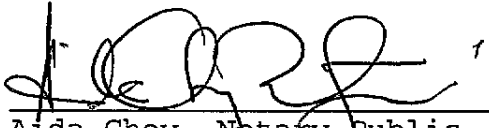

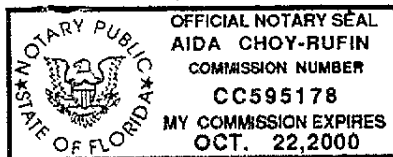

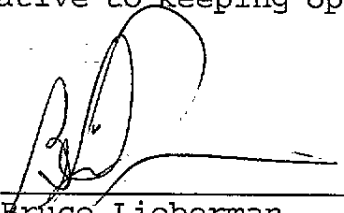
