
ARTICLE VI - PURPOSE AND DURATION

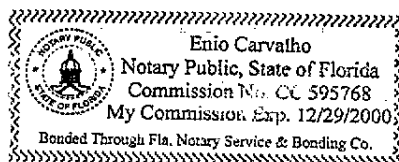
