Article I - Name

The name of this corporation is **Silver Wing Properties, Inc.** The mailing address for the corporation is 2731 N.W. 41st Street, Suite B-3, Gainesville, Florida 32606.

Article II - Duration

This corporation shall have a perpetual existence, commencing on the date of filing these articles with the Department of State.

Article III - Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

Article IV - Capital Stock

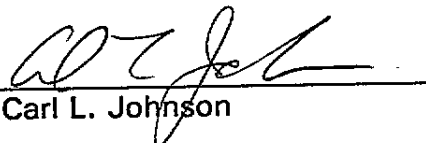
