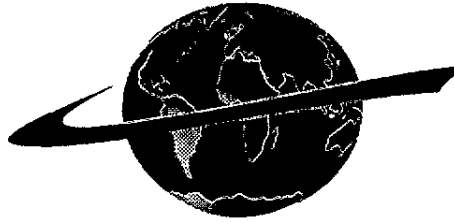

#### Article III




