The number of shares of stock that this corporation is authorized to have outstanding at any one time is 100 shares of \$1 par value common stock.

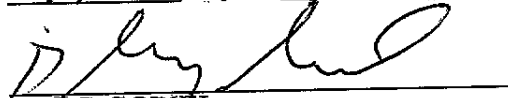

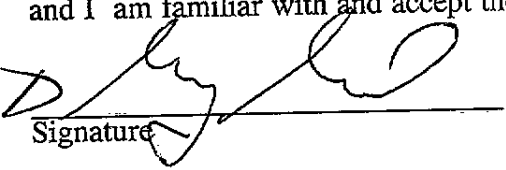
CERTIFICATE OF DESIGNATION OF
