ARTICLES OF INCORPORATION  
OF

ARTICLE I.

NAME

The Name of the Corporation is BEYNI INVESTMENTS, INC.

TERM OF CORPORATE EXISTENCE

ARTICLE VI.

PRINCIPAL OFFICE

ARTICLE VII.

REGISTERED OFFICE AND AGENT


INDEMNIFICATION
