ARTICLES OF INCORPORATION

of

EBC, INC.

Section Management The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopt the following articles of incorporation:

ARTICLE I CORPORATE NAME AND PRINCIPAL ADDRESS

The name of this Corporation is EBC, INC. The principal address of the corporation is 2609 N.E. 22nd Street, Ft. Lauderdale, Florida, 33305.

ARTICLE II **PURPOSE**

The general purposes for which the corporation is organized are:

- 1. To transact any lawful business for which corporations may be incorporated under the Florida Business Corporation Act.
- 2. To do such other things as are incidental to the above or necessary or desirable in order to accomplish the above.

ARTICLE III **DURATION**

The duration of the corporation is perpetual.

ARTICLE IV **CAPITALIZATION**
