**ARTICLES OF INCORPORATION
OF

The undersigned incorporator, for the purpose of forming a corporation under Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

Article 1. Name. The name of the Corporation shall be Frankie R. Brin, Inc.

Article 2. Principal Office. The principal place of business shall be 201 S. Orange Avenue, Suite 1250, Orlando, Florida 32801 and the mailing address of this Corporation shall be 201 S. Orange Avenue, Suite 1250, Orlando, Florida 32801.

Article 3. Shares. The number of shares of stock that this Corporation is authorized to have outstanding at any one time is 25,000 shares of common stock. Such shares shall be of a single class and shall have no par value.

Article 4. Initial Registered Agent and Street Address. The address of the initial Registered Agent of the Corporation is 201 S. Orange Avenue, Suite 1250, Orlando, Florida 32801 and the name of its initial Registered Agent at that address is Frankie R. Brin.

Article 5. Incorporator. The name and street address of the incorporator to these Articles of Incorporation is as follows: Frankie R. Brin, 201 S. Orange Avenue, Suite 1250, Orlando, Florida 32801.

Article 6. Initial Board of Directors. The number of Directors constituting the initial Board of Directors is one. The number of Directors may be increased or decreased from time to time in accordance with the by-laws, but shall never be less than one. The name and address of the initial Director of the Corporation is as follows: Frankie R. Brin, 201 S. Orange Avenue, Orlando, Florida 32801.

Article 7. Duration. The duration of the Corporation is perpetual.

Article 8. Amendment. The Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment to them, and any right conferred upon the Shareholders is subject to this reservation.

Article 9. Commencement of Corporate Existence. In accordance with Section 607.167, Florida Statutes, the date when corporate existence shall commence is the date upon filing of these Articles of Incorporation.


Article 10. Indemnification. The Corporation shall indemnify each Officer, including any former Officers, to the full extent permitted by law.

Article 11. Purpose. The general purposes for which the Corporation is organized are the following.

A. To engage in and transact any lawful business for which corporation may be incorporated under the Florida Business Corporation Act. No other purpose limits this general purpose in any way.

B. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.


