ARTICLE I - NAME

The name of this corporation is JOBO INVESTMENT CORP.

The amount of capital with which this corporation shall commence business shall not be less than Five Hundred dollars ..00/100 - - (\$ 500.00).

ARTICLE XIV - SUBSCRIBERS

The corporation reserves the right to amend or repeal any provision contained in these articles of incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.

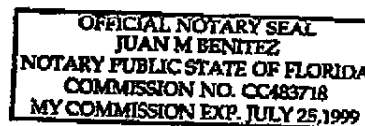
