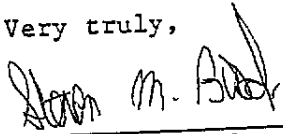

ARTICLES OF INCORPORATION
OF
SYLPOTT INC.

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida

ARTICLE I. NAME

The name of the corporation shall be SYLPOTT INC.

The address of the principal office of this corporation shall be 13720 NW 1st Avenue, Miami, Florida 33168 and the mailing address of the corporation shall be the same

ARTICLE II. NATURE OF BUSINESS

This corporation may engage or transact in any or lawful activity of business permitted under the laws of the State of Florida, the United States or any other state, country, territory or nation.
