The undersigned acting as incorporators of a corporation under the "Florida General Corporating Act." adopt the following Articles of Incorporation for such corporation.

ARTICLE I

The name of this corporation is SUNNY PUBLISHING, INC.

The period of existence for this corporation is perpetual.

ARTICLE III

The purpose of this corporation is to engage in any activities or business permitted under the laws of the United States of America and of the state of Florida.

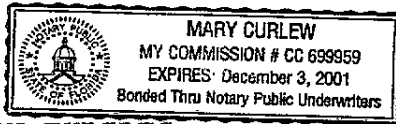
