1. Article I of the Articles of Incorporation of Advanced Graphics, Inc. is amended to read as follows:

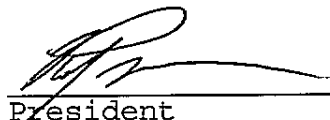

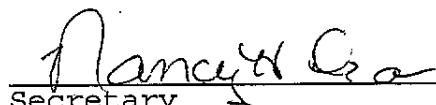
The name of the corporation is Sea Stuffle, Inc.
