ARTICLES OF INCORPORATION OF

The undersigned subscriber to these Articles of Incorporation, hereby executes these Articles of Incorporation to form a corporation under the laws of the State of Florida.

I. NAME AND MAILING ADDRESS

The name of this corporation is Wilber Trucking, Inc., and the mailing address Cinnamon Street, Middleburg, Florida 32068.

II. TERM OF EXISTENCE

This corporation is to exist perpetually. Corporate existence shall commence on February 23, 1998.

III. PURPOSE
