**ARTICLE I  
CORPORATE NAME**

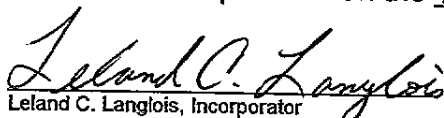
