**ARTICLE I - NAME**

The name of this corporation is SITE UNSEEN, INCORPORATED, a Florida corporation.

**ARTICLE II - DURATION**

This corporation shall have perpetual existence and this existence shall commence on the date of execution and acknowledgement of these Articles.

**ARTICLE III - PURPOSES**

The general purposes for which this corporation is organized are:

## **ARTICLE VIII - ACTION BY STOCKHOLDERS AND DIRECTORS WITHOUT A MEETING**

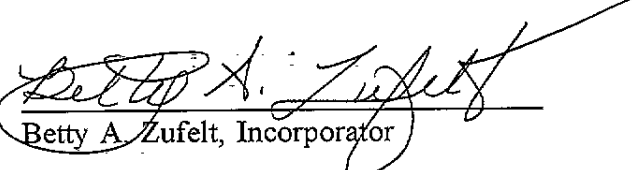
The Stockholders and Directors of this corporation may take action by written consent as provided by law.

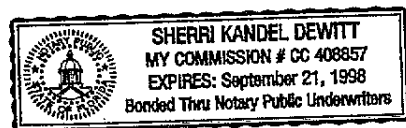

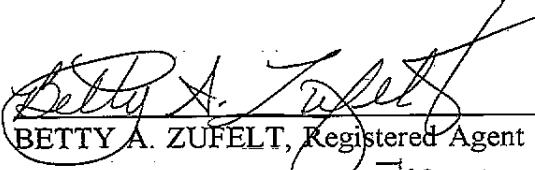
