ARTICLE I

NAME

The name of the corporation is 1001 JUPITER PARK DRIVE, INC.,
hereinafter called the 'Corporation'.

Members of the Board of Directors may participate in meetings of the Board of Directors by means of conference telephone as provided by law.

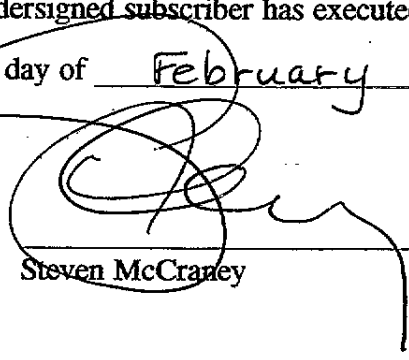
ARTICLE XI

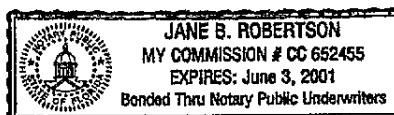
