ARTICLES OF INCORPORATION
OF
BERMUDA BEACH CLUB, INC.

The undersigned incorporator, for the purpose of forming a Corporation for profit under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of this Corporation is:

BERMUDA BEACH CLUB, INC.

ARTICLE II - TERM OF EXISTENCE

The Corporation is to exist perpetually.

ARTICLE III - PURPOSES

The sole purpose for the existence of the Corporation is to serve as the general partner of Bermuda Beach Club Associates, Ltd., a Florida limited partnership and to exercise all powers enumerated in the corporation laws of the State of Florida necessary or convenient to the conduct, promotion or attainment of the business of the Corporation.

ARTICLE IV - CAPITAL STOCK

The shares of stock of this Corporation shall consist of only one class. The number of shares of stock that this Corporation is authorized to have outstanding at any one time is 1,000 Shares of Common Stock having a par value of \$1.00 per share.

ARTICLE X - BANKRUPTCY

In the event management of the Corporation recommends that either the Corporation or Bermuda Beach Club Associates, Ltd., or both, should seek relief under Title 11 of the United States Code (the Bankruptcy Code) by (a) filing a voluntary petition for relief under the Bankruptcy Code or (b) by consenting to the entry of an order for relief in the event of filing an involuntary bankruptcy petition, then it shall be a prerequisite to the filing of a voluntary petition or the consent to filing of an involuntary petition that a unanimous vote shall be made by all the Directors

of the Corporation then serving to file a voluntary petition or consent to an involuntary petition for either the Corporation or Bermuda Beach Club Associates, Ltd.
