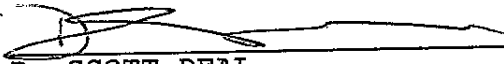
**ARTICLE IX - AMENDMENT**

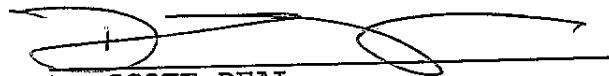
