ARTICLE I. NAME

The name of this corporation shall be
Arma Inc.





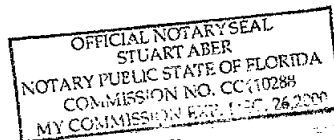
