ARTICLES OF INCORPORATION OF DANIEL E. GALLAGHER, JR., P.A.

The undersigned, for the purpose of forming a corporation profit under the laws of the State of Florida, adopts the following Articles of Incorporation:

Article I Name

Section 1.1. Name. The name of the corporation shall be DANIEL E. GALLAGHER, JR., P.A.

Article II Principal Office and Mailing Address

Section 2.1. Principal Office and Mailing Address. The principal place of business and mailing address of this corporation shall be 166 Highway AlA North, Suite 200-A, Ponte Vedra Beach, Florida 32082.

Article III Capital Stock

Section 3.1. Capital Stock. The maximum number of shares of stock which this corporation is authorized to have outstanding at any one time is 1000 shares of common stock having a par value of \$1.00 per share.

Section 3.2. Restriction on Transfer of Stock. The shareholders may, by bylaw provision, by shareholders' agreement recorded in the minute book or by endorsement on each stock certificate, impose such restrictions on the sale, transfer, or encumbrance of the stock of this corporation as they may see fit.

Article IV Initial Registered Agent and Address

<u>Section 4.1.</u> Name and Address. The name and street address of the initial registered agent of this corporation is Daniel E. Gallagher, Jr., 166 Highway AlA North, Suite 200-A, Ponte Vedra Beach, Florida 32082.

Article V Incorporator

Section 5.1. Name and Address. The name and address of the incorporator of this corporation is Daniel E. Gallagher, Jr., 166 Highway AlA North, Suite 200-A, Ponte Vedra Beach, Florida 32082.

Article VI Duration

Section 6.1. Duration. This corporation shall exist perpetually. Corporate existence shall commence on the date these Articles are executed, March 1, 1998, except that if they are not filed by the Department of State of the State of Florida within five days, exclusive of legal holidays, after they are executed, corporate existence shall commence upon filing by the Department of State.

Article VII Purposes

Section 7.1. <u>Purposes</u>. This corporation is organized for the purpose of transacting any of all lawful business permitted under the laws of the United States and of the State of Florida.

Article VIII Directors

Section 8.1. Number. This corporation shall have one (1) director initially. The number of directors may be increased from time to time as provided in the bylaws, but shall never be less than one (1).

Section 8.3. Compensation. The board of directors is hereby specifically authorized to make provision for reasonable compensation to its members for their services as directors, and to fix the basis and conditions upon which such compensation shall be paid. Any directors of the corporation may also serve the corporation in any other capacity and receive compensation therefor in any form.

<u>Section 8.4.</u> <u>Indemnification</u>. The board of directors is hereby specifically authorized to make provision for indemnification of directors, officers, employees and agents to the full extent permitted by law.

Article IX Bylaws

Section 9.1. Bylaws. The initial bylaws of this corporation shall be adopted by the directors. Bylaws shall be adopted, altered, amended or repealed from time to time by either the shareholders or the board of directors, but the board of directors shall not alter, amend, or repeal any bylaw adopted by the shareholders if the shareholders specifically provide that such bylaw is not subject to amendment or repeal by the directors.

Article X Amendment

<u>Section 10.1</u>. <u>Amendment</u>. This corporation reserves the right to amend or repeal any provision contained in the Articles of Incorporation, and any right conferred upon the shareholders is subject to this reservation.
