ARTICLES OF INCORPORATION

OF

Sajin Brothers Import and Export, Inc.

ARTICLE ONE

The name of the corporation is **Sajin Brothers Import and Export, Inc.** The principal address of the corporation is: 1908 Funston Street, Hollywood, Florida 33020.

ARTICLE TWO

The period of its duration is perpetual.
