ARTICLES OF INCORPORATION OF GRIDIRON SPORTS MANAGEMENT, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE ONE

The name of the Corporation is GRIDIRON SPORTS MANAGEMENT, INC.
