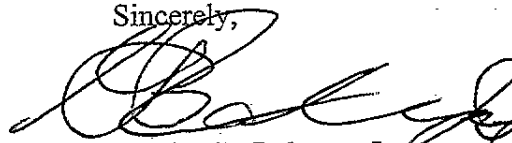

ARTICLES OF INCORPORATION

OF

DONNA L. BLAIR LCSW, P.A.

ARTICLE I - NAME

The name of the corporation is Donna L. Blair LCSW, P.A.

ARTICLE II - EFFECTIVE DATE

The effective date and the date of commencement of corporate existence shall be March 1, 1998.

ARTICLE III - PURPOSE

This corporation is organized for the following purposes:

- a. To engage in the practice of clinical social work and to carry on all services ancillary thereto. The practice of clinical social work is the sole and exclusive professional service to be rendered by this corporation;
- b. To own real and personal property, enter into contracts, and to carry on any business necessary, incidental, or ancillary to the accomplishment or furtherance of the purposes or objects of this corporation;
- c. To invest its funds in real estate, mortgages, stocks, bonds, or any other type of investment; and
- d. To do everything necessary, proper, or convenient for the accomplishment of any of the purposes set forth in these articles, and to do every other act, necessary, incidental, or ancillary to the corporate purposes which is not forbidden by the laws of the State of Florida or by the provisions of these articles of incorporation.

The purposes of this corporation shall be carried out only through officers, employees and agents, who are licensed or otherwise legally qualified to render clinical social work services in the State of Florida.

ARTICLE IV - PRINCIPAL OFFICE

The principal place of business of this corporation is 221 Dune Drive, Santa Rosa Beach, Florida 32459, and the mailing address of this corporation is P.O. Box 1642, Santa Rosa Beach, Florida 32459.

ARTICLE V - SHARES

The number of shares of stock that this corporation is authorized to have outstanding at any one time is 10,000 shares having a par value of \$1.00 per share.
