

ARTICLE I

The name of the corporation is **MANE STREET HAIR DESIGNERS & BARBERING, INC.**

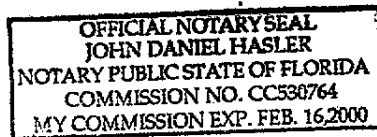




