#### ARTICLES OF INCORPORATION

OF

#### EXECUTIVE COVERING, INC.

The undersigned Incorporator of these Articles of Incorporation is a natural person competent to contract and hereby forms a corporation for profit under the General Corporation Act and other laws of the State of Florida.

ARTICLE I. NAME AND PRINCIPAL OFFICE

The name of this corporation is Executive Covering, Inc. and its principal office is located at 630 Roberts Road, Jacksonville, Florida 32259.

ARTICLE II. DURATION

This corporation is to exist perpetually.

ARTICLE III. PURPOSE
