Dear Ms. Skinner:

The reason for the requested 1120 filing extension and the long delay before actually filing the company's 2001 return was due to the following reason:

Even though Advanced Concepts is a corporation, I am the only employee. In late December 2000, I suffered a subarachnoid hemorrhage (ruptured aneurysm in the brain). Normally 67% of the individuals stricken with this condition die and of the remaining 33%, 50% of those are permanently disabled. I have been extremely fortunate in being able to recover, but it has been a slow process and quite frankly the enclosed tax return had to be relegated to a lower priority. If you need verification of the medical condition, I will be happy to forward the names of the attending physicians in West Palm Beach and Miami, Florida.
